During his life Athol was a dedicated member of the Goolgowi community serving on many clubs and associations, often as president.

Athol served as a Carrathool Shire Councillor for over 40 years. First elected to Council's A riding in 1963, he was then elected Deputy Mayor in 1969 and served as Mayor of Carrathool Shire from 1983-2004.

Athol sat on many committees including Australian Wheatgrowers, Barley Committee and NSW Farmers Association.

INFRASTRUCTURE NEWS

Lachlan River Stabilisation Works

A newsletter has been released outlining the next stage of the Lachlan River Stabilisation Works project, showing areas along the river where it is recommended structural works are implemented to reinforce two potentially problematic areas.

MESSAGE FROM THE MAYOR - COVID-19

MEETING MATTERS

Request to go to Open Tender

Council resolved to go to open tender for Line Marking and Bitumen Supply Services.

Rankins Springs Flood Study

At the May meeting Council approved an application for funding into a flood study of the Rankins Springs township and the assembly of a Flood Committee should the application be successful under the governments next round of Floodplain Management Grants.

Lower Speed Limit Application

Council resolved to approve an application to lower the speed limit on The Springs Road. Council will now apply to the required regulatory authorities to approve the proposed 70km speed zone, 1.5km in length, located east of the current 50km speed zone on The Springs Road, Hillston.

WHAT YOU NEED TO KNOW! OWNING A CAT OR DOG IN NSW

- All companion animals must be microchipped and registered before they are 6 months old.
 - NOTE: This is a 2 step process, microchipping your pet is NOT the same as completing your pets lifetime registration.
- From 1 July 2020 additional annual permits are required for dangerous dogs and cats who are not de-sexed (by age 4 months). These annual permits are payable on top of your pets lifetime registration fee:
 - Non de-sexed cats \$80 annual permit Exceptions include cats that are lifetime registered before 1 July 2020 and cats kept for breeding purposes by registered breeders.
 - Dangerous dog \$195 annual permit
- Remember, it is your responsibility as the owner to update the animals owners information - DO NOT leave this up to the new owner, if the dog is involved in a serious incident or declared dangerous, YOU as the named owner of the dog may be fined.

Under the *Companion Animals Act 1993* section 11 the owner of an identified companion animal must notify Council of any animal information changes within 14 days of the change occurring.

To update your current or old animals details, simply contact or visit Council for a change of ownership form.

WATER & SEWER NEWS

Clearing Works

Council have undertaken works to clear 2.4km of vegetation along Council's water main pipeline around Erigolia. These works provide staff with adequate access for operational and maintenance purposes.

Goolgowi Sewer Mains Assessment

Last week Council engaged RSP Environmental Service to carry out a condition assessment of the Goolgowi sewer main. A report of the assessment will be presented to Council to help determine any future maintenance and relining work necessary.

Water Meter Reading

Council would like to notify residents that water meter readings are being conducted between 23 May 2020 and 10 June 2020. Please ensure all gates are unlocked, dogs are restrained and water meters are visible and clear of any overgrown vegetation during this period. If Council officers are unable to read your meter you will be issued with an estimated reading.

DEVELOPMENT PROPOSAL DEVELOPMENT APPLICATION DA2016/043 MODIFY 2, LOT 4 DP1220390 'THE RANCH' 149 BACK HILLSTON ROAD, TABBITA

Council has received a Development Application to modify a Livestock Intensive Industry (Poultry Production Facility) on Lot:4 DP:1220390 'The Ranch' 149 Back Hillston Road, Tabbita. In accordance with s 4.46 of the *Environmental Planning and Assessment Act 1979*, Council hereby provides Notice of the proposed development, which will also be assessed as Designated and Integrated development.

The name of the applicant is VOAG 4 and the Consent Authority for this development is Carrathool Shire Council, PO Box 12, Goolgowi NSW 2652. The approval authority for Integrated development is NSW Environment Protection Authority under s.43 of the *Protection of the Environment Operations Act 1997*.

The proposed development modification provides for the relocation of a water storage dam of reduced capacity and the construction of a new retention basin in the location of the former water storage dam.

The proposed development is Designated Development under the meaning of s 4.10 of the *Environmental Planning and Assessment Act 1979*, as being a livestock intensive industry for the commercial production of birds accommodating more than 250,000 birds.

The Development Application and supporting documents may be inspected at the offices of Carrathool Shire Council located at 9-11 Cobram Street, Goolgowi, and the Department of Planning, Industry & Environment Offices from Monday 18 May 2020 up until close of business on Monday 1 June 2020. During this time any person may inspect these documents and make written submissions to Carrathool Shire Council. Any submissions made will be considered public document.

Council advises that, as per Clause 118(5)(d) of the *Environmental Planning and Assessment Regulation 2000,* if Council approves the application there is no right of appeal to the NSW Land and Environment Court by an objector.

PUBLIC EXHIBITION DRAFT OPERATIONAL PLAN 2020/21


