Purpose

Council has adopted urban area water supply boundaries to enable the effective management of demand and supply and to establish rating boundaries. Council will supply potable water to properties within the established boundaries. Connection of properties within the declared boundaries is carried out and charged in accordance with the prevailing charge per Council's adopted schedule of fees and charges.

All requests for connection beyond the urban water boundaries are subject to determination and resolution by Council. Extensions of mains metering and other costs associated with provision of town water beyond the boundaries will be at the cost of the benefitted property owner and prevailing service charges applied.

- 1. Council's Urban Water Supply Boundaries are as shown on the water boundary maps 1-6 contained in the schedules attached to this policy.
- 2. In the event of the subdivision of:
 - Lot 1 DP 749566
 - Lot 119 DP 755189
 - Lot 28 and Lot 4 DP 224089 Parish of Redbank,
 - Lot 134 DP 755189

the boundary will be adjusted to include the existing dwelling only.

- 3. That Council provide access to urban water to the following property by way of metered service located on Council reserve in Lachlan Street, Hillston. Property owners benefitted are responsible for underground installation and maintenance of the connecting pipeline across the Lachlan River:
 - Lot A DP 439969






