Purpose

The purpose of this policy is to inform the community of the statutory restrictions and acceptable limits which apply to the keeping of certain animals for domestic purposes, to identify which animals are prohibited within Carrathool Shire Council and to give guidance and advice to persons inquiring about the keeping of animals for domestic purposes.

Definitions

Council: Carrathool Shire Council

Companion Animal: A dog, a cat, or any other animal that is prescribed by the

Companion Animal Regulations (the Regulations) as a companion animal. As at the date of the implementation of this Policy, no other animals have been classified as companion

animals.

Reference

This policy compliments other legislation and where is it silent on matters referred to in the following legislation such matters must be followed in accordance with the legislation.

- Companion Animals Act, 1998
- Local Government Act, 1993
- Local Government (General) Regulation, 2021
- Protection of the Environment Operations Act, 1997
- Prevention of Cruelty to Animals Act 1979
- The Impounding Act, 1993

Policy statements

Introduction

This policy applies to animals kept for domestic reasons and include companion animals, pets or those animals kept for hobby interests. This Policy is not intended to replace or supersede the requirements of the *Companion Animals Act 1998* or the *Prevention of Cruelty to Animals Act 1979*.

Where it is intended to keep animals for any commercial purposes, it is necessary that a development application be submitted to Council and planning consent obtained. Consent to the operation of Commercial Animal Establishments may not be allowed where the Council considers that the proposal would be harmful to the amenity of the locality.

Special provisions may be given to people who temporarily house certain animals as part of a legitimate foster care arrangement or care for pets of family and friends while they are on holidays etc. so long as health and amenity of the neighbourhood is preserved.

Basic Requirements

The number of animals that may be kept at a premise should not exceed the number prescribed as appropriate to the kind of animal listed in the Table of Requirements included in this policy.

The kind of animal that is suitable to be kept at any premises will be determined having regard for the size of the available yard area and the distance to the nearest dwelling or other prescribed building. Certain statutory requirements also apply as noted in the table.

It should not be assumed that animals of all kinds may be kept on premises that are part of a multiple dwelling development.

Animals should be kept in a manner which does not:

- create unclean or unhealthy conditions for people or for the animals.
- attract or provide a harbourage for vermin.
- · create offensive noise or odours.
- cause a drainage or dust nuisance.
- create waste disposal or pollution problems.
- create an unreasonable annoyance to neighbouring residents or fear or safety.
- cause nuisance due to proliferation of flies, lice, fleas or other insects.

Animals should not be kept at premises used for the manufacture, preparation, sale or storage of food for human consumption.

Suitable shelter(s) should be provided for all animals. Certain species of animals are required to be kept in cages to prevent escape or attack by predators. Generally, other animals are to be securely enclosed with adequate fencing to prevent escape.

Dogs Leash Free Areas

To work alongside the Companion Animals policy following areas are designated leash free areas in accordance with the Companion Animals Act:

Hillston the area known as "Desathlon" (Dinosaur) Park, or the Lachlan River

Walking Trail on the western side of the Lachlan River.

Goolgowi from the eastern side of Cobram Street, north from 60km road sign near

the intersection at the water storage tanks, to the intersection with Brady's Road, then back towards town to the 60km road sign which will

include the area known as Bunyip Walk.

Rankins Springs the area bounded by Mon Road and Lake Street from Main Road 371

(Lake Cargelligo Road) to the point where Suburb Street would intersect

with Mon Road.

Carrathool the area surrounding the Carrathool Waste depot to the south of town.

Merriwagga the area bounded by the railway land to the west and Devon Street

between Lallat and Marne Streets and Charney and Fleury Streets, and

Aix Street between Marne and Charney Streets."



HORSES

Council may permit upon application the keeping of horses within towns and villages in accordance with the Horse Free Areas shown in the attached maps.

ADDITIONAL ANIMALS

Any cattle, goats and sheep shall not be kept on premises within the town and village boundaries without the prior approval of the Council.

Council will not permit the keeping of pigs within the town and village boundaries.


